

## Conditions of Participation in the PICS FOR PEACE – Photo Contest

### 1. Organizer of the photo contest

The photo competition is organized by the Foundation "Remembrance, Responsibility and Future" (EVZ Foundation).

### 2. Conditions for Participation

Anyone who has been part of a EUROPEAN FOR PEACE youth exchange as a participant is eligible to participate.

A participant takes part in the photo competition by submitting his/her pictures **via** Instagram or E-Mail.

By submitting photos to the contest, the participant(s) agree to the conditions of participation and the data protection conditions (see point 7 of the conditions of participation).

Participation must take place within the deadline specified in the photo competition. The following serves to verify compliance with the deadline: by e-mail the date of receipt, in the case of Instagram the date of publication.

### 3. Procedure and contents

- a. Choose up to three photos you took at a EUROPEANS FOR PEACE international youth encounter. Your favorite exchange buddies, sights you visited, emotions you captured – the photos can show anything you like. Whatever kind of camera you used – digital, phone, analog – is just fine.
- b. Follow us, post your photo(s) on your Instagram account, tag @europeans\_for\_peace and use #europeansforpeace. Please add a title to your photo and – only if you want to – a description. Deadline is the 30<sup>th</sup> of September 2020!
- c. If your photo makes it in the second round, we will DM you and ask for your full name, age, home country and the project you participated in.
- d. A jury of two EUROPEANS FOR PEACE team members, one public relations expert of the EVZ Foundation and two alumni of the programme, will elect the three best photos. The winners will be asked to provide us with the photos by email.
- e. You're one of the Top Three? Congrats!! You will win 500€ and your photo will be published on our website and social media channels.

### 4. Evaluation of the Photographs and Prizes

A jury of three EUROPEAN FOR PEACE team members and two former participants will select three photos from all entries.

The winners will be notified by the EUROPEAN FOR PEACE team on Instagram and Facebook. If someone submitted a photo via email, this person will also be informed via email.

The three winners will each receive 500€ by bank transfer, which can be used for any purpose. A photographer can receive a maximum of 500€ for only one of his submitted photos.

#### 5. Rights of Use/ Exemption from liability by the participant

By participating in the photo competition, the participants grant the EVZ Foundation simple as well as temporally, spatially and content wise unrestricted rights of public reproduction, distribution and duplication, non-commercial use as well as free use in the context of presentation, advertising and all other activities of the EVZ Foundation. It does not matter in which media this happens, including print, online, film and social media portals such as Facebook.

An image used in this way will be provided with the corresponding copyright by the EVZ Foundation as follows: "© first name, last name".

The participant assures,

- that he/she can dispose of the above rights and
- that the submitted picture is solely from him/her personally,
- he/she holds all rights to the submitted image,
- has the unrestricted exploitation rights of all parts of the image,
- that the picture is free from rights of third parties
- as well as in the representation of persons no personal rights are violated.

In the case of persons, works, signs or other objects depicted in it, the participant has obtained the necessary consent from the persons concerned.

The participant will insure the above in writing upon request. Should third parties nevertheless assert claims for violation of their rights, the participant shall indemnify the organizer from all claims.

#### 6. Premature termination of the photo contest and exclusion from the contest

The EVZ Foundation reserves the right to interrupt or terminate the photo competition at any time without prior notice and without giving reasons.

#### 7. Data Protection

In order to participate in the photo contest, it is essential to submit data when submitting pictures and to accept the current privacy policy.

Personal data will only be processed and stored to the extent that they are necessary for the execution of the competition. By submitting photos, participants expressly agree that the data provided (name, age, home country, project they participated in) may be published.

All participants are free to withdraw from the competition at any time by sending a revocation to [europeans-for-peace@stiftung-evz.de](mailto: europeans-for-peace@stiftung-evz.de)
